## Covid-19 Update: Living with Covid-19 Plan

Following the Government's announcement on the ending of all Covid restrictions in England, we have been considering the implications for us as a school. In doing so, we are, as ever, following the advice and guidance of the experts at the Department for Education (DfE) and the NHS.

Whilst the Government's announcement is clear that Covid remains present in society, it does bring an end to the series of legal and advisory measures that have been in place in schools over the last two years. I would like to thank everyone in the school – students, parents, staff and visitors – for following the laws and the guidance so that we have been able to minimise the risk of transmitting the virus within the school.

Our priority, however, remains the safety and wellbeing of everyone in our school community and I know that we will all continue to act sensibly and considerately in the interests of everyone's health.

## Lateral Flow Testing

Secondary school students are now **no longer expected to test twice a week** but, if your child does develop symptoms associated with Covid-19, I would urge you to continue to test them for the virus.

- We will provide Year 7-11 students who require more tests a further box during form time on Friday 4<sup>th</sup> March.
- We have a limited number of boxes remaining so will distribute our stock equally amongst these 5 year groups.
- Tests will be free of charge until 1<sup>st</sup> April so do request them from the NHS or your pharmacist if you need them.

## What if my child tests positive?

If your child does test positive for Covid-19, I would ask that they continue to **self-isolate for at least five days and only return to school after having two negative lateral flow tests on consecutive days**.

Whilst doing so is no longer the law, it is very sensible practice and helps us minimise the risk of Covid-19 spreading in the school. If we are all careful and considerate, we can minimise the risk of the virus circulating amongst us.

If your child does test positive and will be absent from school please, as usual, inform the school via the school absence line 01536 515644 or by emailing <u>studentabsence@kba.uk</u> or by contacting us via the Arbor application.

Children and young people remain eligible for a vaccination against Covid-19. If your child has not already had theirs, they are available via the NHS website <u>Book or manage a coronavirus (COVID-19) vaccination - NHS (www.nhs.uk)</u>.
